- replacement of a windscreen, part of a motorcycle or vehicle on which the vignette was displayed during the warranty period.**

Mandatory attachments:

- the removed vignette, or the part of the windscreen with the vignette (if the entire serial number on the vignette is not legible, the accompanying coupon should also be submitted). If the removed vignette is half-year, monthly or weekly, the validity period must be evident, otherwise the purchase invoice must be attached.
- a copy of the invoice for replacing the windscreen, or a copy of the invoice for replacing the part of the motorcycle, or
- a document or copy of a document on the warranty replacement of a windscreen, part of a motorcycle or vehicle issued by the workshop which replaced it;
- a photocopy of the document on the handover of the vehicle for destruction and of the document on the cancellation of the vehicle from the official registry of registered vehicles. **The documents have to be enclosed with their translations into Slovenian language issued by a sworn translator.**

The person liable for tolls should apply for a replacement vignette within 30 days in order to exercise this right.

I understand that the unjustified obtaining of a replacement vignette on the basis of false information is a criminal offence.
