- the toll for all the vehicles of the removal service provider is included in the uniform maximum allowed service prices
 in the price list above and the removal service provider must not, in any case, make an extra charge to the service
 payer,
- the service provider may charge up to <u>+30%</u> of the service prices in the above price list for works outside regular working hours solely for works performed during the night between <u>8 p.m.</u> and <u>7 a.m.</u>, for works performed on Saturdays (with the exception of work between <u>7 a.m.</u> and <u>12 noon</u>), and for works performs on <u>Sundays</u> and <u>holidays</u>,
- the service provider must <u>make an agreement in writing</u> with the driver/owner of the vehicle (service payer) <u>for towing</u> the vehicle to a specified location,
- the start of the intervention is the start of the intervention at the location of the service provider,
- the end of the intervention is when the service provider returns to its location,
- *such as winter conditions, closure of one tunnel tube etc. Services performed by the selected service provider are paid by DARS, d.d. within 30 days after the invoice is issued. The price also includes towing services required due to objective reasons (e.g. a vehicle stops or slips off the road on a motorway or expressway hill due to objective reasons, such as a goods vehicle has proper equipment but slips off the road anyway; a goods vehicle without proper equipment slips off the road, which stops the goods vehicles driving behind it, and which, consequently, cannot continue to drive – the vehicles are ready to drive independently after the towing), performed during out-of-hours duty.
